## **CLEANING, MAINTENANCE, DISINFECTIONS**

To maintain your goggle in good condition:

- 1. Do not use abrasive materials, clean and rinse in warm soapy water and dry with a soft cloth.
- 2. Any part of eye-protector which are in contact with the wearer shall be disinfected by alcohol.

## FIELD OF USE (PROTECTION CAPABILITIES AND PERFORMANCE CHARACTERISTICS)

This safety goggle is designed to protect the user against eye injuries through mechanical impact, flying particles.

#### **DURATION OF USE**

Inspect for damage regularly. When the frame has become hard and brittle, the safety goggle should be replaced.

- Do not modify or alter the eye protector.
- Pitted or scratched lens reduce vision and seriously reduce protection and should be immediately replaced.
